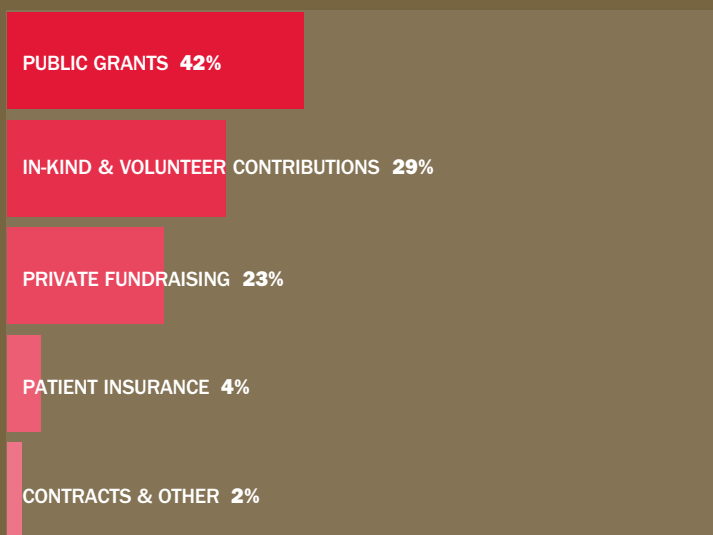

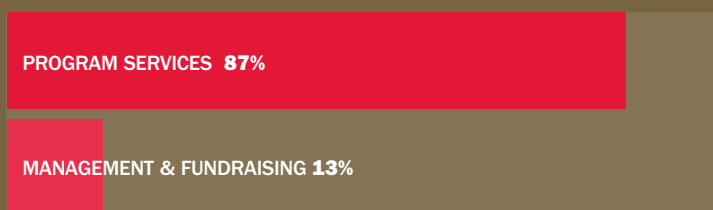

## W E L C O M E   T O   F O U R T H   S T R E E T   C L I N I C

**For more than 25 years, Fourth Street Clinic has helped homeless Utahns improve their health and quality of life by providing high quality health care and support services. By increasing homeless Utahns' access to primary care, Fourth Street Clinic is a major partner in promoting community health, ending homelessness and achieving across-the-board health care savings.**

### **HISTORY**

The mid-1980s brought a dramatic rise in Salt Lake City's homeless population. During this time, Salt Lake City's downtown was revitalized and several substandard, single-room occupancy hotels that offered rooms for just a few dollars a night and required no leases were razed and redeveloped. In total, 800 low-income housing units were torn down, displacing 1,000 very poor residents from their homes and jobs. With no public plan to rapidly re-house or support these residents, homelessness moved from a sporadic, temporary experience to endemic and intergenerational.

To fill the service gap, nonprofits such as Fourth Street Clinic began to form. Founded in 1988, Fourth Street Clinic began as a triage clinic staffed with one, part-time nurse who relied heavily on hospitals for patient treatments.

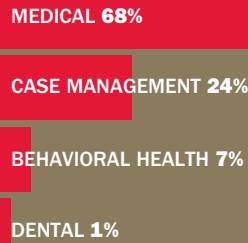
Today, with a staff of 50 and a volunteer network of more than 150, Fourth Street Clinic is a AAAHC Patient Center Medical Home that serves 4,100 homeless men, women and children with 25,000 medical, mental health, substance abuse, dental and case management visits. Fourth Street Clinic has also been an active partner in a countywide effort to reduce homelessness by restoring low-income housing opportunities. This initiative has developed 940 permanent-supportive housing units in Salt Lake County and has reduced the number of people experiencing long-term homelessness by 72 percent.<sup>1</sup>

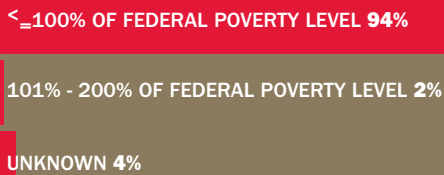

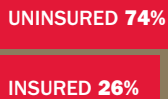

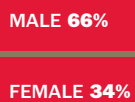
## INCOME



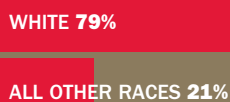
## INSURANCE STATUS



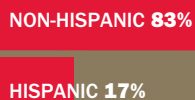
## GENDER

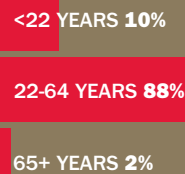

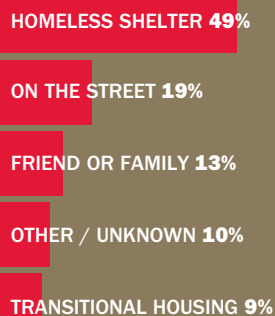
## PATIENT DEMOGRAPHICS

In 2013, Fourth Street Clinic served 4,144 homeless patients — a 10% increase over 2012. The ALSAM Foundation Pharmacy at Fourth Street Clinic grew by 20% — filling over 53,000 prescriptions.

## 2013: A YEAR OF FIRSTS

**2013** was a year of growth—in patients, in services and in quality improvement. First came AAAHC Patient Centered Medical Home Accreditation, which nationally certifies that children, women and men who experience homelessness in Salt Lake City receive some of the best primary medical care in the country. Next came the successful completion of a \$2.9 million capital expansion project that doubled our footprint and added an on-site dental clinic.

Already, the Dental Clinic is producing big smiles. For the first time, patients have a chance at saving their teeth with regular cleanings, fillings and crowns and restoring lost teeth with dentures. The number one cause of death among those experiencing homelessness is also being addressed with the launch of an integrated substance abuse program.

Fourth Street Clinic's community partners, volunteers, board of directors, consumer advisory board and staff should be incredibly proud of the infrastructure that has been built. Already, 10 percent more patients are being served and 20 percent more prescriptions are being filled. With continued support, Fourth Street Clinic is perfectly positioned to grow throughout 2014 and beyond.

**F**ourth Street Clinic is part of a national network of private, nonprofit Community Health Centers. Born out of the Civil Rights Movement, Health Centers galvanized the social justice ideal that all Americans, regardless of where they live or their ability to pay, should have equal access to comprehensive and high-quality primary care services. For 45 years, Health Centers have



developed in medically underserved communities and targeted vulnerable populations (i.e. people experiencing homelessness). Today, Health Centers are a major component of our nation's health care safety net.

Because Health Centers accept most forms of insurance, but also offer discounted fees to low-income, uninsured patients, 21 million Americans call over 8,000 Health Centers their medical home. Fourth Street Clinic is a Health Care for Homeless Center—providing services to those who experience homelessness and discounting all services to zero. Grants and private fundraising underwrite the cost of care, and volunteers and donated medications stretch these resources further.

A recent report found that in addition to closing the health care access gap, Health Centers also make significant contributions to their local communities' economic health. In 2013, Utah's 38 urban and rural Health Centers provided over \$22 million in uncompensated care, saved our health care system \$230 million and had a \$151.5 million economic impact.<sup>1</sup> Fourth Street Clinic alone generated \$5 million in health care savings and contributed \$7.2 million to Salt Lake County's economy through job creation in 2013.<sup>2</sup>

Fourth Street Clinic is proud to build upon this long-standing tradition of social justice and equality and gives a big “thank you” to donors, volunteers and community partners for the very important role you play in making sure that Utah is healthy both inside and out.
